Call for Nominations to the Board

Under the terms of the Constitution of the Elevating Work Platform Association of New Zealand, nominations are called for the three (3) Board member positions.

A vacant board member position is available to fill, following on from last year's AGM.

Current Board members Steve Boyde of EHL Solutions and Dean Van Buuren of Design Engineering are the two board members up for rotation as board members.

Steve and Dean have indicated they both will stand again.

The Association opens all eligible persons, to seek nomination to contest these positions on the board.

The successful candidates must be willing to serve a term on the EWPA board following confirmation of their appointment at the Association AGM. The successful candidates will serve a period of three years on the board.

The election of Board members shall be conducted as follows:

- Call for Board member nomination (This notice)
- Nominations close Friday, 11th July 2025.
- Where more nominations are received than open positions, an electronic vote election by eligible members will take place. Communication of the results from the election will be announced at the AGM.
- Should less nominations than open positions be received, the current member will be confirmed back onto the board at the AGM.
